Staff Dress Code Guidelines

Mr. Rheingans reviewed proposed guidelines for appropriate staff apparel. A statement will be added that if you look like you are mowing, doing aerobics, or gardening, it is not appropriate for school. Members would like to have more specific examples added. Principals will be required to enforce these guidelines. The board is passionate about this topic. All employees must portray a professional image as they are role models for students. This will come back to the committee in August.

#1004 - School Improvement Through Shared Decision-Making

Mr. Rheingans presented this policy for discussion. He recommends adding language to the administrative guidelines that would guide meaningful discussion with the D/SILT that would provide input to ensure a productive committee structure. Gathering this group is a real opportunity to do some data collection. This will be discussed again at an upcoming meeting.

#6204 - Acceleration

Mr. Rheingans introduced some proposed language "It is the intent of the district to provide all students with rigorous instruction. The following guidelines outline the data that will be utilized to inform our discussion about the proper placement of a student; however, if a student meets a majority of the measurements, and parent/guardian input is such that they believe that their student possesses the motivation, work ethic and desire to be successful in an accelerated program, the student will be given an opportunity to be placed in that program."
