Senior High School Renovation

Transportation Department Asphalt Replacement Project

Hempstead and Senior High School Tennis Court Repair Project

Contractor has completed scope of work on both projects.

Hoover Elementary School Bus/Parking Lot Project

The main bus drive was poured last Friday. Handrail on the ramp is yet to be completed. Project will be completed by the start of school.

Irving Elementary School Bus/Parking Lot Project

Underground work is completed. Concrete sidewalk and drive have yet to be completed. This project has an extended deadline due to the extent of the work involved.

Eisenhower Elementary School Gymnasium Roof Replacement Project

Project is essentially complete. Inspection is Wednesday.

Hempstead High School Athletic Improvements

A meeting is scheduled Wednesday to discuss replacing dugouts and correcting storm water issue on first base line. Phase I to be completed by the spring.

Senior High School Athletic Improvements

Buildings and Grounds is waiting for the final design draft from the architect.

Eisenhower Elementary School and Jefferson Middle School Roof Repairs

Forum and Senior Roof Repair Projects-Wind Damage
