Ms. Bradley called the meeting to order at 4:01 p.m. at the Forum.

The agenda was approved as submitted.

#### Activities Council Update

Amy Hawkins, Director of Athletics/Activities, indicated that the Activities Council met today. She shared Grades 9-12 Activity Participation Data. In 2015-16, the district had 55% of entire student enrollment involved in one or more activity. In 2016-17 participation increased to 63%. The majority of participants have a GPA of 3.1-4.0.

#### Threat Assessment Protocol

Mae Hingtgen, Learning Supports/Equity Liaison, reviewed the history of threat assessment in the district. She shared the new Threat Assessment Protocol, which is a more comprehensive procedural system. Threat assessment is a violence prevention strategy that involves: identifying student threats to commit a violent act, determining the seriousness of the threat, and developing intervention plans that protect potential victims and address the underlying problem or conflict that stimulated the threatening behavior. The goals of threat assessment are to keep schools safe and to help potential offenders overcome the underlying sources of their anger, hopelessness, or despair.

#### Summer School Update

Cindy Steffens, Director of Elementary Education, reported on 2017 summer programming attendance. She shared data for grades 1-2 students that were invited to attend summer school, either through the district program or at St. Marks or the DREAM Center. 427 students were invited due to their level of need in reading instruction. 243 students did not take advantage of summer school. The goal is to increase the number of students attending. School connectors will be an integral part of the school/parent connection. Tammy Duehr, Lead Instructional Coach, shared summer academic achievement data.

#### **FAST Testing Update**

Ms. Duehr reviewed the 2017-18 FAST (Formative Assessment for Students and Teachers) Literacy Screener Data. K-1 - 24% of students were high risk, 25% some risk, 51% low risk Grades 2-6 - 20% of students were high risk 23% some risk, 29% low risk, 28% above average

## Certified Enrollment Update

Superintendent Rheingans reported that the district's certified enrollment decreased by 48.97 students. This will affect the budget for next year along with additional expenses in IPERS, as well as possible increases in insurance.
